Student Internet Access Agreement & Rules and Code of Ethics

INTERNET ACCESS AGREEMENT:

The Seattle Public Schools makes available to students access to computers and the Internet. Through the Internet, students may have access to databases, websites, and sometimes email. Students might also publish their own work on the World Wide Web. Students are expected to use computers and the Internet responsibly and for school-related purposes only.

As a condition of my right to use the Seattle Public Schools Internet service, I understand and agree with the following:

- Use of the Seattle Public Schools Internet service is a privilege. If I violate any conditions of use them that privilege may be taken away by school district administrators and other consequences may follow.
- **Use of the Internet is for school-related purposes only.**
- District administrators will decide what constitutes violation of Internet use policies. Violations include, but are not limited to:
 - Transmission of or deliberate access to obscene, indecent, harassing, defamatory or otherwise offensive material in any form;
 - Any deliberate attempt to harm or destroy data on any system on the Internet;
 - Unauthorized installation, storage, or distribution of copyrighted software or materials;
 - Violations of district policies or federal and state laws.
- School district administrators have the right to review any material sent, mailed, or store in District computers, including web sites and emails. The District can edit or remove any material that it believes may be unlawful, obscene, indecent, harassing, or otherwise objectionable.
- **Do not give out your name, picture, telephone number, or home or school address while using the Internet.**
- The District does not guarantee that the functions of the Internet service will be error-free or uninterrupted.
- All other related student policies are applicable. Please review the "Student Rights and Responsibilities" pamphlet.

RULES AND CODE OF ETHICS:

I agree to follow these rules and establish this code of ethics in all of my work using Roosevelt High School computers:

- I will not use computer resources for non-academic related activities.
- I will not play games on any school computer.
- I will not damage computer equipment or maliciously alter computer settings.
- I will only use the Internet to search areas that are appropriate to my class curriculum.
- I will not give my computer password to another student.
- I will use printer paper supplies wisely.
- I will not look at non-academic streaming video.
- I will not use a proxy server.
- I will not access chat rooms.
- I will work in ways that will not disturb others.
- I will not alter other students' files.
- I will only save materials in my personal folder that are appropriate for educational use.
- I will not engage in plagiarism which means copying others' work from the computer (or anywhere else) and claiming it is as my own.

I have read the above statements and agree to follow them. Any violations of this Agreement may result in losing my Internet privilege, and other disciplinary consequences.
